  - (j) This document records the entire agreement between the Business and I/The Minor and Parent/Guardian in relation to the Activity and my participation in it.
  - (k) I/The Minor and Parent/Guardian have not relied upon any advice, representations or inducements by or on behalf of the Business in deciding to:
    - (i) participate/allow the Minor to participate in the Activity; and
    - (ii) sign this document.

#### **RISK WARNING**

- 1. I/The Minor and Parent/Guardian acknowledge that I/we have been warned of the Risks of the Activity.
- 2. I/The Minor and Parent/Guardian acknowledge that the Activity may also involve other risks not noted in the Risks of the Activity listed on page 1.
- 3A. The Business has placed signs around the site on which the Activity is to be performed warning of the risk of injury. I/The Minor and Parent/Guardian have read the signs and understand the warnings provided.
- 3B. The Business has provided me with oral warnings of the Risks the Activity and the risks of physical harm in participating in the Activity.

### ASSUMPTION OF RISK-PHYSICAL INJURY and DEATH

1. Notwithstanding the significant risks of physical harm and injury inherent in the Activity, some of which are noted above, I/The Minor and Parent/Guardian agree to participate in the Activity at my own risk.

# WAIVER, RELEASE AND INDEMNITY

- 1. "I/The Minor and Parent/Guardian agree that the provisions of Competition and Consumer Act 2010(Cth) and any similar state legislative provisions (which provide for an implied warranty that services be rendered with due care and skill and that any material supplied in connection with those services will be reasonably fit for purpose) are excluded other than the extent to which those provisions allow the providers of recreational services to contract out of the implied warranties in so far as they relate to liability for physical injury or death from the Activity".
- 2. I/The Minor and Parent/Guardian agree to release and hold harmless the Business its servants, employees and agents from and against any liability arising out of any physical injury or death of The Minor and Parent/Guardian or any other person arising from or in connection with my participation in the Activity whether such physical injury or death was caused directly or indirectly by negligence, breach of contract or any way whatsoever other than where the physical injury or death was caused solely by the negligence of the Business, its servants, employees or agents.
- 3. I/The Minor and Parent/Guardian agree to indemnify and hold harmless the Business, its servants, employees and agents from all claims, damages and expenses arising out of or resulting from my/The Minor and Parent/Guardian participation in the Activity. This indemnification extends to all claims made by/The Minor and Parent/Guardian and any other person against the Business, its servants, employees or agents in respect of any physical injury or death arising out of or in connection with my/The Minor and Parent/Guardian participation in the Activity, other than where the physical injury or death was caused solely by the negligence of the Business, its servants, employees or agents.

Further I/The Minor and Parent/Guardian understand that I/we will not be permitted to continue the Activity and no refund will be given.
- 3. I/The Minor and Parent/Guardian accept the recommendation from the Business to include ambulance cover in my private health fund agreement
- 4. I/The Minor and Parent/Guardian agree that if I/we suffer any injury or illness I/we agree that the Business may provide or arrange evacuation, first aid and medical treatment at my expense.
